**MINUTES OF THE 39<sup>TH</sup> ANNUAL GENERAL BODY MEETING HELD ON THE 2ND DECEMBER 2020  
AT VILLA MARIA, # 28, K NO. 335, ATHITHI LAYOUT, S.T. HALLI, ANANDAPURA, MSS LAYOUT, T.C. PALYA,  
BENGALURU – 560036 AT 11:00 A.M.**

The Vice-President welcomed those present.

One minute silence was observed for the deceased members of MSS.

**1. PRAYER**

The meeting started with a prayer by Fr. Soosai.

**2. MESSAGES**

There were two messages; one from the Archbishop of Bangalore, Rev. Peter Machado and one from Sr. Christine, benefactress of MSS.

Mr. Francis Colaso read out these messages.

**3. MINUTES**

The minutes of the AGM held on 12th September 2019 were confirmed.

**4. VICE - PRESIDENT'S ADDRESS**

The Vice-President, Mrs. Maria Pinto, was happy to welcome everyone to the 39th Annual General Body Meeting of the Maria Seva Sangha.

She remarked that as all those who had gone through this report may have noticed, this was not the President's address, as is usual practice, but rather the Vice President's address. This is because the elected President, Mr. Brian Albuquerque, resigned from the post on December 31, 2019, on account of personal reasons, and she being the Vice President had functioned since then as the Pro-tem President. As MSS entered its 40th year, it was with a sense of gratitude that she wished to acknowledge the hard work, dedication and commitment of the founder, Mrs. Ethel Brito, the other founding members, Air Cmdre Melville Rego, Mr. Gladwyn Fernandes, Mr. Peter Sinai, Mrs. Joan Fernandez, and Mrs. Blanche Alvares, to name a few, and long standing Governing Body members, Mr. Francis Colaso, Mrs. Therese Rasquinha, Mr. Philips Cherian and Mr. Philip De Costa.

Born in the year 1981, from the simple vision of Mrs. Ethel Brito to serve the poor and marginalised, all the members of MSS are proud to say that the Maria Seva Sangha has positively impacted the lives of thousands of individuals, across age groups, communities and religions, over the past 39 years.

The work at the Maria Seva Sangha, she explained, is spread across six projects, of which, the members are actively involved in five of them, namely, the Mid-day Meal Scheme, the Sponsor-a-Child Scheme, the Medical Health Care Scheme, the Senior Citizen's Residence and the Educational Scholarship Scheme. As regards the 6th project, the Social Housing Project, a majority of the plots in the layout have been allocated and all the house owners are happy and currently residing there.

She presented some of the highlights of the year gone by:

The Mid-day Meal Scheme under the chairmanship of Mr. Philip De Costa provided nutritious and wholesome food to 1772 children in 18 schools in the year 2019-20. The Mid-day Meal Scheme has been successful in addressing children's attendance at school and improving their attention and performance.

The Sponsor-a-Child Scheme under its chairperson Mrs. Maria Pinto enabled 171 children across 8 schools to receive quality education and complete yet another academic year. She was pleased to report that 6 of the sponsored children successfully completed the class X Board examinations this year.

Villa Maria, the Senior Citizen's Residence under its chairperson Mrs. Therese Rasquinha has been providing maximum comfort and wholesome, tasty food, to the 11 individual residing there. Additional guidelines have been put into place to keep all the residents safe during this Covid 19 pandemic.

A few more beneficiaries of the Mathrudhan Social Housing project under the Chairmanship of Mrs. Therese Rasquinha, built their houses this year taking the total number of completed constructions to 23.

Medical Health Care Scheme, also under the chairmanship of Mrs. Therese Rasquinha, provided calcium supplements to 1123 children and de-worming, iron, vitamin B12, paracetamol and no-cold tablets to 1146 children across 11 schools.

The Educational Scholarship Scheme headed by Mr. Brian Albuquerque, until his resignation and after that by Mr. Francis Colaso, disbursed Rs.12,58,100/- in the form of scholarships to 26 students.

She was happy to thank the Chairpersons of each of these projects for the good work they have put in during the past year.

A significant achievement of the year 2019-20 was when MSS received a grant of Rs. 3,44,500/- towards the Sponsor-a-Child scheme from the Cipla Foundation. This was the result of the initiative of our Secretary, Mrs. Therese Rasquinha, and the work and persistence of both Mrs. Rasquinha and the chairperson of the Scheme, Mrs. Maria Pinto. She thanked Cipla Foundation for their contribution towards our cause.

The FCRA registration of MSS, which had expired a few years ago, was not renewed, despite having made the renewal application multiple times. As per a recent government notification, all NGOs are required to make a fresh application for FCRA renewal. As the foreign donations to MSS were minimal in the past few years, the Governing Body unanimously decided not to pursue the renewal application.

She brought to the notice of the members present that Mr. Anand Veigas, the Executive Director, left the organisation on the 31st of May, 2020. She wished to place on record the Governing Body's appreciation of his service and contribution to Maria Seva Sangha over the past 13 years.

As the year drew to a close, the Maria Seva Sangha, like everyone else was faced with the Covid 19 pandemic. While pandemic did not affect the work of the year just passed, which is the subject matter of this report, she wished to draw attention to the fact that this pandemic was severely impacting the work of MSS in the year currently underway. She explained that the months since the start of the pandemic and the lockdown were extremely difficult, not just for the organisation, but also for the beneficiaries, most of whom are children. With many schools and colleges shut, there was still a great amount of uncertainty around when things would return to normal. With children not going to school, apart from the fact that there has been a break in their education, most of them have also been missing out on the mid-day meal. She hoped and prayed that the situation would return to normal, sooner rather than later.

The pandemic and the lockdown also adversely affected the economy, which was already on a downward trajectory last year. This adversely impacted the donations. However, she believed, that there was tremendous

potential in all of the members working together, to achieve greater heights. She expressed her deep gratitude to all the donors and sponsors, who supported us through this difficult period. She assured all those present that the Governing Body of Maria Seva Sangha, would continue to pursue the vision of our founder, Mrs. Ethel Brito, to serve the poor and the marginalised, so that they could have a better tomorrow.

She wished to thank Mr. Philips K. Cherian for his contribution as Treasurer of MSS. She also, very specially thanked Mrs. Therese Rasquinha, the Secretary, for her untiring dedication and efforts, undiminished enthusiasm and commitment to MSS over the past more than 20 years.

She also wished to thank the office staff: Mrs. Sheeja Sunil, Ms. Nandhini and Mr. Anthony R for their good work. She specially thanked the staff of Villa Maria, Mr. Mathew Raj, Mrs. Deepa Thankachan and Mr. Allan Joseph for the excellent work, in keeping the residents comfortable and safe, especially during the pandemic.

And, finally, she thanked each and every one of those present for taking the time to attend the Annual General Body Meeting of the Maria Seva Sangha.

She wished everyone to stay safe and all the very best.

## 5. **PROJECT REPORTS:**

### a) *Mid-day Meal Scheme:*

As the Chairperson of the project was not present, Mr. Francis Colaso read out the report.

The Mid-day Meal Scheme provides poor, undernourished children with freshly cooked, hot meals on all school working days throughout the academic year. The number of children provided with hot meals in the last academic year was 1772 (in 18 schools). The cooking and feeding arrangements are randomly monitored by our members. As regards cleanliness and nutrition, the same are supervised through the cooperation and dedicated efforts of the school staff, who also supervise the preparation.

The success of the Mid-day Meal Scheme has been confirmed and appreciated by all the Principals of these schools and is very gratifying to us, in the Maria Seva Sangha. The proof of this is in the regular attendance of these children at school, the improvement in their general health and better immunity towards common illnesses.

This programme commenced in 1987 with just 50 children in one school and our main reason for promoting this project at that time was to draw innocent, poor children away from the streets and evil influences resulting therefrom and help them to remain at school and receive an education. This is valid even today.

Regarding the financial aspect of this key project, it must be noted that a significant percentage of our donors are small businesses. Consequently, with the general down turn in the economy, our donations have suffered accordingly. As a result we had a shortfall in funds, which was made good by grants/loans from other projects.

This was even before the arrival of the COVID PANDEMIC. The pandemic put paid to our chances of getting even a minimal amount of donations for the current financial year. The only saving grace is that schools have been closed till October and so the outflow of cash has been correspondingly reduced for this academic year.

For the balance of this academic year we shall have to be dependent, to some extent, on grants from other projects.

Meanwhile, we have been forced to refuse requests from a number of schools to join our Mid-day meal scheme.

Looking to the future, we have tried contacting professional fund-raising agencies but our experience has been disappointing. Still, we are trying to work out some arrangement. Your suggestions and help regarding fund raising would be welcome to help us raise funds.

In view of the above, it is my earnest request to all existing donors to please increase your donations or help us find new donors. We can give you a 50% deduction under sec 80G of the income tax act.

At the end of the day, if we are still short of funding we shall be forced to do one or more of the following:-

- Reduce the number of students-so as to ensure quality of meals
- Reduce subsidy per student- this is likely to affect the quality and/or quantity of meals.

Finally, let me close by stating that the Midday meal scheme, which is focused on small unaided schools in the semi urban and rural areas around Bangalore, a laudable initiative of MSS.

#### **b) Villa Maria – Senior Citizens' Residence:**

Mrs. Rasquinha told those present that the Facilities manager – Mr. Mathew Raj and the supervisor, Mr. Allan Joseph take care of the maintenance and running of the home and the residents on a daily basis. They are very dedicated and do a brilliant job. Ms. Deepa Thankachan, a qualified nurse – continued to do a wonderful job monitoring and taking care of the needs of the residents. She also reviewed the menus periodically and made a huge effort to see that as many special dietary needs as possible, were taken care of. She said that members of the committee visit the Residence regularly and give their feedback and suggestions, and take care of any problems that arose from time to time. They met with the residents and addressed any issues they had.

Unfortunately, because of the Covid 19 pandemic, the situation had become less free for the residents and help at Villa Maria. In spite of that, Mr. Mathew Raj did a remarkable job, persisted and got a pass during the first lockdown, and ensured that he was present and able to take care of the smooth running of the home. As a result of this, and the presence of Ms. Deepa Thankachan and Mr. Allan Joseph, Villa Maria ran on oiled wheels during the whole of the pandemic and the residents were safe, comfortable and happy.

She said that in order to ensure the safety of the residents, guidelines were put in place for visitors to the Residence. Exit and entry forms had to be filled for residents who wished to leave the home on personal work, thanks to which all the residents lived through the pandemic unscathed. She appreciated their co-operation, without which this could not have been achieved.

She said that one resident had left the home for personal reasons.

She thanked and expressed her gratitude, on behalf of MSS, to the fathers who had very kindly offered their services to help in taking care of the spiritual needs of the residents of Villa Maria and of the layout. She was also grateful to the Parish priest of St. Anthony's Parish, Thambuchettyalya, for his help and cooperation.

She said that several enquiries from senior citizens about occupancy for both, short term stay and long term stay were still coming in and that she was hopeful that, very soon, Villa Maria would have even more residents. Flyers have been printed with details of Villa Maria, for distribution.

She strongly requested all members of MSS to visit Villa Maria and the residents there. She would be very happy if members of MSS wish to conduct any entertainment or counselling programmes for the residents. If anyone desired to do so they could contact the chairperson of the project, who would give them whatever help or information they may require.

She informed them that senior Citizens' day was celebrated on 21st August with a special menu for lunch and some fun and games for the residents.

A Christmas party was held on 19th December. All the MSS members and donors were invited. Carols were sung and a special Christmas menu was catered for lunch and a few games were organised for all those present. The function was well attended. The residents and all those present enjoyed both celebrations.

She welcomed all comments, suggestions and assistance.

She assured everyone that every effort was being made to provide the best facilities and maximum comfort for those senior citizens who resided there.

#### **c) Mathrudhan – Social Housing Project:**

Mrs. Rasquinha informed those present that there was nothing much to report regarding the project except that this year a few more beneficiaries started building their homes in the layout. Almost all the beneficiaries have now built their homes on their sites. It is a fully functional layout and the residents are very happy. There are still a few sites where the beneficiaries have not built their homes because of certain difficulties they are facing.

#### **d) Medical Health Care Scheme:**

Mrs. Rasquinha informed those present that calcium supplements were given to 11 schools in December 2019. Many children, especially in the rural schools benefit from this project. The schools are:

1. Shrishti Special Academy
2. Cottolengo Residential School
3. YWCA – Arathi Day Centre

1123 children benefitted from this.

She said that de-worming tablets, iron tablets and vitamin B 12 tablets were given to 11 schools in June 2019. First aid boxes, cough syrup, paracetamol tablets and no cold tablets were also given to these 8 schools in June 2019. The schools are:

5. St. Charles Rural School

1146 children benefitted from this.

She lauded the schools that do a wonderful job and administer the supplements regularly to the children.

Unfortunately, because of the covid 19 pandemic, schools were closed from March and were unable to function. As a result, as is the case for the Mid-day meal programme as well, no supplements could be given to the schools in June 2020. She was confident that MSS would resume giving the vitamins and other supplements as soon as the schools re-opened.

She said that MSS is very fortunate to have a few generous donors like Mrs. Lorna Mathias, Mrs. Mariam Suhail and all our other donors whom she thanked for their generosity that enabled MSS to keep the project going. She expressed her gratitude to them. She also made an appeal for more donations to help sustain this project and explained that it costs approximately only Rs.100/- per child, for the academic year.

#### **e) Sponsor-a- Child Scheme:**

Mrs. Maria Pinto informed those present that in the year 2019-20, the Sponsor-a-Child scheme supported 171 children across 8 schools. This was significantly lower than the number sponsored in 2018-19 on account of the change in our policy.

She said that, in February 2019 MSS approached the Cipla Foundation to look at the possibility of providing funds towards our Sponsor-a-Child programme. She explained that it was a long drawn out process of providing documentation and collecting details from the schools. She was happy to announce that at the end of it all, the project received a grant of Rs. 3,44,500, towards the fees of 111 children across schools. She expressed her gratitude to the Cipla Foundation for their grant and also their recognition of our commitment towards making education accessible for the poorest of the poor.

She explained how MSS' experience with the Cipla Foundation prompted the Governing Body to review its policy towards the selection of schools, where children would benefit from the programme. After much

deliberation and discussion, the Governing Body decided that the beneficiaries of the Sponsor-a-Child programme should be the poorest of the poor and the amount provided should completely cover the fees, not just subsidise them. Hence, as a policy, MSS has discontinued sponsoring children in schools where the fees are high. The committee understood that this would have caused great inconvenience to the children that were being sponsored, but it was also understood that if parents are sending their children to such schools, they do not necessarily belong to the poorest of the poor category. Therefore, the Governing Body has also revised some of the formats that were used to collect details from the schools, after its experience with the Foundation, to make the collection of information more comprehensive.

She said that on account of the pandemic and the lockdown, exams in most schools and across classes could not be held in the month of March 2020. Class 10 exams too were delayed and were finally held in July 2020. 6 students from St Charles school cleared the Board exam. She wished them the best in their future endeavours.

She said that MSS was also unable to send out the usual progress reports to individual sponsors in the month of May, as is the usual practice, as most schools were closed and there was great uncertainty on when they would reopen. Thank you letters were however sent to all the sponsors giving them an update on the situation and, with an appeal to continue their sponsorship of the children assigned to them. After much follow-up, MSS did receive progress reports from 4 schools, but are yet to receive the reports from the other 4 schools.

She said that MSS has also not received fee and student details for the year 2020-21 from any of the schools, on account of the pandemic and the great uncertainty. She said that details of their sponsored students would be sent to them as soon as updates from the schools were received.

She expressed her deep gratitude to the donors of the project, the Cipla Foundation, Messers Give India, Angana, Mr. Prasad Krishna, Mr. Hari Prakash, Mr. Neginder Bansal Mr. Ronald Fernandes and a host of other individuals who have supported this scheme in their personal capacity. Including the Cipla Foundation, funds were received from 3 new donors last year who together with the regular donors, contributed Rs. 5,86,000/- towards the Sponsor-a-Child scheme. She thanked all of them for their generosity.

She explained how the past few months were an extremely difficult period for MSS. Donations saw a sharp decrease on account of the pandemic. She assured those present that the Governing Body would, however, continue its efforts to raise funds through donations so that the number of children who benefit from the Sponsor-a-Child scheme could be increased.

#### **f) Educational Scholarship Scheme:**

Mr. Francis Colaso informed those present that he had taken over from Mr. Brian Albuquerque, who resigned in December 2019. He said that after the onset of the pandemic, education has been affected. He said that in the current year not much could be given.

This scheme is intended to help financially weak students to obtain funds to pursue Higher education and thereby, uplift themselves and their families. The educational scholarship is offered without interest to deserving students who otherwise would not have been able to pursue higher studies due to financial constraints. A number of students have availed of this scheme to realize their dreams by doing their Bachelor's degrees in Arts, Science, Commerce, Engineering and Business Administration. This scheme also covers professional and technical courses that are job oriented.

Stringent screening of the applicants has resulted in zero loss of capital. This ensures that funds are available to continue this project.

**8. ANY OTHER BUSINESS:**

Mrs. Maria Pinto asked the members present if there were any points they would like to bring up for discussion.

a) Mrs. Jean Rego commended MSS and its Governing Body on the good work done and also commended the good work of the staff. She wanted to know if, after shifting the office to KRP, the Governing Body was considering an increase in the travel allowance for the staff.

Mrs. Rasquinha responded and told her that the move was very recent, only 2 weeks, and that the Governing Body was definitely considering the proper remuneration for its staff.

b) Mrs. Jean Rego said that she thought it was a good idea to have a hamper to raise funds for MSS. she asked if the committee would consider it.

Mrs. Rasquinha said that the committee would be very happy to execute this if Mrs. Rego could please help with some man power as the MSS Governing Body was very short staffed. She said that the committee would fully support her execution of this move to raise funds for the projects of MSS. Mrs. Rego said she would try and implement this in 2021. Mrs. Rasquinha thanked Mrs. Rego for her suggestion.

- c) One person from among those present introduced himself as Fr. Babu, and said he was from the Archbishop's house, and had just taken up the post of being in charge of 'Properties' there. He asked for some clarifications regarding the agreement between MSS and the Archdiocese. However, he was unable to make clear what clarifications, exactly, he sought. One of the members present, Mr. Sunil Rasquinha, asked him what clarifications he wanted, but he was unable to get his point across. After some time members of the Governing Body, Mr. Phillips Cherian, Mrs. Maria Pinto, Mrs. Therese Rasquinha and Mr. Francis Colaso told him that if he wanted any clarification he was most welcome to write down the points on which he sought this clarification and the committee would be very pleased to respond.

Fr. Babu was informed that the annual report was sent to the Archbishop every year giving all the details of all developments year by year. He asked whether the Archbishop was asked if he approved of these developments or not. To which Mr. Sunil Rasquinha responded that, as Maria Seva Sangha is a registered society, the annual report goes out every year well in advance to all members including the Archbishop and that everyone has time in which to raise any points they wish to. Once the minutes of the meeting are passed it is considered that the report is in order and accepted.

Mrs. Maria Pinto said that if the Archbishop had any doubts he could write to the Association and that they would respond.

Mr. Colaso told Fr. Babu that any information the Archbishop required, in the past, had always, been given. And that MSS had, in the last 39 years, kept the Archbishop informed at every level especially with reference to No. 28. Sannathamannahalli, KRP.

Mrs. Rasquinha gave a brief history of the property and details of the developments with regard to the property and of the role MSS played in this, over the last 31 years. She said that MSS had sent files with the documents pertaining to the development of the Property, at every stage, to the Archbishop's office for which acknowledgements were given. Especially as it was given to MSS to use for the benefit of the poor and underprivileged, and for which purpose, specifically, the BDA had given all sanctions to develop the property. Yet about a month ago she was asked to send another file as no records were found there. She said that because of shifting the office and the AGM and Christmas, she would require some time to complete compiling the file to send it, once again, to the Archbishop's office.

## **9. TALK BY MSGR. C. FRANCIS:**

Msgr. C Francis told those present that the Archbishop had requested him to be present at the AGM and had asked him to speak a few words. He conveyed his greetings to all present. He commended the good work of MSS. He said that this was a unique day – 02-12-2020 and wished well for everyone. He said that he had worked with and was closely associated with MSS especially with the registering of the sites in the MSHP layout to the allottees, and that he knew the properties of the archdiocese well. He thanked the office bearers for their collaboration in serving the underprivileged. He thanked the new office bearers as well.

## 10. ELECTION OF THE OFFICE BEARERS:

The members of the committee withdrew and the election of the new members to the committee was entrusted to Prof. B. J. Mathews.

Prof. Mathews conducted the election. He said that there was no contest and therefore no election was necessary. He announced the names of the members of the new Governing Body.

Maria Seva Sangha serves members of the weaker sections of society through the midday meal programme and medical health scheme for children in rural and urban schools; sponsoring the education of children, especially the girl child, and enabling them to complete their schooling; financial aid at post

school level for professional courses which enables them to be self-sufficient; providing sites to the middle income group of people who would otherwise be unable to afford housing in Bangalore. This project was possible with the help of the Archdiocese when they entrusted 3 acres and 36 guntas of land to MSS to develop for the upliftment of the underprivileged; and last but not least, helping people at post retirement age by providing comfortable, safe and secure accommodation thus enabling them to live with dignity and self-respect in the evening of their lives.

Some highlights of the activities for the year gone by are:

The **Mid-day Meal Scheme**, under the chairmanship of Mr. Philip De Costa, has helped 1,772 children in 18 schools in 2020-21 by providing them with dry rations. These are the families of school students in rural areas like Kollegal, and in urban areas of Mysore and Bangalore. We are keenly awaiting the reopening of schools and easing of restrictions so that we will be able to continue the project once again.

The **Sponsor-a-Child Scheme** under its chairperson Mrs. Maria Pinto supported 42 students in 3 schools during the year, all in rural schools.

**Villa Maria**, our Senior Citizen's Residence under its chairperson Mrs. Therese Rasquinha has been working even through the lockdown and pandemic, attending to the needs of the residents in every aspect, with routine medical monitoring, timely Covid vaccination, following Covid protocols for residents, visitors and staff. Nutritious, tasty food, physical and mental welfare and recreational and spiritual needs are also being taken care of on routine basis. For this we have to thank Dr. Henrietta De Costa, and Dr. Regina for their voluntary and regular visits to the residents. We would also like to thank Koshy's hospital for extending their co-operation and timely assistance when our residents have needed hospitalisation.

In the **Mathrudhan Social Housing Project** under the Chairmanship of Mrs. Therese Rasquinha, most of the allottees have built their houses taking the total number of completed constructions to 23.

Due to the Covid-19 restrictions and schools not being functional, activities under **Medical Health Care Scheme**, also under the chairmanship of Mrs. Therese Rasquinha, could not be carried out. Once schools reopen we will be resuming the activities this year.

The **Educational Scholarship Scheme**, headed by Mr. Noel Pereira and earlier by Mr. Francis Colaso, disbursed Rs. 2,66,700/- in the form of scholarships to 5 students. As and when the colleges and institutions commence normal functioning and offline classes, we are hopeful of helping more needy and eligible students.

I thank all our donors for their continued support to various projects during the year and earlier years. This has enabled us to run the projects without a break and support more and more beneficiaries every year.

I would like to thank the Chairpersons of each of these projects for the good work they have put in during the past year.

I would like to thank our office staff Mrs. Sheeja Sunil, Ms. Nandhini and Mr. Anthony for their good work. A special thanks to the staff of Villa Maria, Mr. Mathew Raj, Mrs. Deepa Thankachan, housekeeping and kitchen staff for the excellent work in looking after the residents with love,

## PROJECT REPORTS 2020-2021

### MID-DAY MEAL SCHEME 2020-21



The Mid-day Meal Scheme provides poor, undernourished children with freshly cooked, hot meals on all school working days throughout the academic year.

As a consequence of the pandemic most schools have remained shut during the last academic year and even in this academic year, schools have just opened partially. Due to the financial restraints of this project, we have tried raising funds via professional fund raisers but the experience has been very disappointing.

The effect of the school closure has been very pronounced on the rural schools rather than on the urban schools.

In the rural areas most parents are either farm labourer or migrant labourers. To earn some money students in the rural areas are pressured to leave school permanently and start working to supplement the family income.

Therefore, the secretaries of the schools requested us to continue to provide subsidies for Mid-day meals for these rural schools and in turn they will provide raw materials (rice, dal, oil etc.) to students on weekly basis. Besides they would encourage students to study informally by giving them unofficial tutorial classes once a week. This, they hope, will keep the children attached to the school and provide for their nutritional and educational needs.

In this way we hope to reduce the number of under fed and under nourished school children.

This has resulted an out flow of approximately Rs.60,000/- per month.

In conclusion we look forward towards your continued support for this project.

### **SPONSOR-A-CHILD PROGRAMME 2020-2021**

The year 2020-21 was a difficult and challenging year for all schools and school children across the country, and it was no different for the schools and children that we support through our Sponsor-a-Child programme. While some schools innovated by taking the *classrooms to the children*, schools remained closed for most part of the year and the children lost out – both in terms of new learning and probably also forgetting much of what they had previously learnt. However, three of our schools, continued with their classes, to whatever extent was possible. These were, St. Anthony's School, R.C Kannada School and St. Charles School. In the month of July 2021, we reimbursed fees amounting to Rs. 1,78,000/- for 42 children across these three schools, for the academic year 2020-21. We are however, still awaiting the report cards of the children.

We have been informed by St. Anthony's School, that 16 sponsored students successfully completed class 10 during the year 2020-21, though we are yet to receive their marks cards. We wish these students the very best in their future endeavours.

We are grateful to our regular donors who have continued to support us this past year. Letters were sent to the donors to keep them apprised of the situation with the schools and requesting them for the contributions, so that the schools could be paid when required. We received a total of Rs.1,11,005/- in donations between April 2020 and March 2021 from them.



On account of the pandemic and the difficulties faced by people across the country, our donations have seen a sharp decrease. At the same time, the number of children that we sponsored last year also saw a sharp decline. We pray that things will return to normal soon, children can return to school and continue their education. We on our part will continue our efforts to raise funds so that we can support an increasing number of children through our Sponsor-a-Child programme.

and helping Deepa in monitoring the health of the residents. She does a splendid job and is very diligent in her work.

A Christmas party was held for the residents on 17<sup>th</sup> December 2020. Mr. Noel Pereira arranged for Santa Claus to visit the residence and interact with the residents. He conducted some games, Christmas carols were sung, a sumptuous lunch was organised and everyone had a joyful time in keeping with the spirit of Christmas. MSS had to retire Mr. Allan Joseph from his supervisory duties in July this year. His advanced age was a main factor in this decision. On behalf of the Governing Body, I thank Mr. Allan Joseph for his service and wish him a peaceful, happy retired life.

To ensure the safety of the residents, the guidelines that were put in place for visitors to the home in 2020, continued. Exit and entry forms had to be filled for residents who wished to leave the home on personal work. We appreciate their co-operation, without which this could not have been achieved.

One new resident joined the residence in July 2021.

On behalf of MSS I would like to thank and express my gratitude, to the fathers who have very kindly offered their services to help in taking care of the spiritual needs of the residents of Villa Maria and of the layout. We are also grateful to the Parish priest of St. Anthony's Parish Thambuchettyalya for his help and cooperation.

We continue to receive several enquiries from senior citizens about occupancy for both, short term stay and long term stay. We are hopeful that, very soon, we will have even more residents. Thanks to Mr. Chetan Crasta the website has been updated and MSS's online presence has been increasing. Flyers have also been printed, with details of Villa Maria, for distribution.

I urge all members of MSS to visit Villa Maria and the residents there. We will be very happy if members of MSS wish to conduct any entertainment or counselling programmes for the residents. If anyone desires to do so they can contact the chairperson of the project, who will give them whatever help or information they may require.

Senior Citizens' day was celebrated on 21<sup>st</sup> August with a special menu for lunch and some fun and games for the residents.

D] BASIS OF PREPARATION , CRITICAL ACCOUNTING ESTIMATES AND JUDGEMENTS, SIGNIFICANT ACCOUNTING POLICIES AND RECENT ACCOUNTING PRONOUNCEMENTS - ESTIMATION ON ACCOUNT OF UNCERTAINTIES RELATING TO THE OUTBREAK OF GLOBAL HEALTH PANDEMIC ON COVID-19

On March 11, 2020, the World Health Organisation declared COVID-19 outbreak as a pandemic. Responding to the potentially serious threat that this pandemic has to public health, the Indian Government has taken a series of measures to contain the outbreak, which included imposing multiple 'lockdowns' across the country, from March 22, 2020, and extended in phases upto 31/03/2021 and thereafter. The lockdowns and restrictions imposed on various activities due to COVID - 19 pandemic have posed challenges to the carrying on of the charitable activities of the entity including operation of the Senior Citizen Residence home of the Society. This has resulted in liquidity issues. With the lifting of the partial lockdown restrictions, the Entity has started re-commencing its activities being situated in the non-containment zones, after establishing thorough and well-rehearsed safety protocols. The Entity expects all its activities to become operational in a phased manner after the lockdown is lifted. The Entity has assessed the potential impact of COVID-19 on its capital and operations sustainability, liquidity position, ability to service debt and other financing arrangements. The Entity is presently debt-free and reserves the option to raise finances from banks and institutions for working capital needs and for long-term fund requirements, if required. The Entity is presently in a comfortable liquidity position to meet its commitments. The Entity has also assessed the potential impact of COVID-19 on the carrying value of its Property, Plant & Equipment and other assets appearing in the financial statements of the Entity. In developing the assumptions and estimates relating to the future uncertainties in the economic conditions because of this pandemic, the Entity as at the date of approval of these financial statements, has used internal and external sources of information and based on current estimates, expects to effectively utilise and/or recover the carrying amounts of these assets. The impact of the global health pandemic may be different from that estimated as at the date of approval of these financial statements and the Entity will continue to closely monitor any material changes to future economic conditions.

E] GOING CONCERN-

The Entity faces significant uncertainties due to COVID-19 pandemic outbreak which have impacted the operations of the Entity adversely. The Management of the Entity has paid special attention to the recent COVID-19 pandemic outbreak and its associated existing and potential impact on the Entity's assumptions, future cash flows and operational projections. The Management has considered the Entity's cash flow forecasts and the expected compliance with the Entity's financial covenants for a period of not less than 12 months from the date of approval of these financial statements. Based on this review, the Management has a reasonable expectation that, taking into account reasonably possible changes in performance of its activities, the Entity will be able to continue in operational existence and discharge its liabilities and realise the carrying amount of its assets as on March 31, 2021 and otherwise comply with its financial covenants at least for the next 12 (twelve) months. Accordingly, the Entity continues to adopt the going concern assumption in respect of its income yielding activities, in the preparation of its financial statements.
